RDS Advises Unitrade On Its ACE Market Listing On Bursa Malaysia



We wish to congratulate Unitrade Industries Berhad (Unitrade) on its successful listing on Bursa Malaysia Securities Berhad (Bursa Malaysia) on 14 June 2022. Unitrade is one of the largest building material wholesalers and distributers in Malaysia.

Unitrade's initial public offering (IPO) is the largest listing on the ACE Market of Bursa Malaysia by market capitalisation since the market's inception in 2009. Its enlarged share capital totaling 1.56 billion shares at an issue price of 32 sen per share gave Unitrade a market capitalisation of RM500 million at its opening on the morning of its listing.

Unitrade raised RM100 million through its IPO to enhance its inventory count and product variety, to construct a new pipe fabrication centre and to repay bank borrowings. Unitrade will be among the first in Malaysia to construct a new pipe-fabrication centre to broaden its value-added service offerings to its customers.
