C4 Center Apologises To Rosli Dahlan For Falsehood And Slander

The Center to Combat Corruption and Cronyism (C4 Center) is an NGO that declares itself to fight corruption and government abuses. Its principal is Cynthia Gabriel and its other directors are Dato' Hjh Sutinah binti Sutan, Prof. Dr. Edmund Terence Gomez and Azrul Mohd Khalib.

On 25.3.2021, C4 Center posted on its website, Twitter and Facebook page, a false and highly defamatory story about Rosli Dahlan. That story had gone viral and taken a life of its own that vilified Rosli Dahlan which brought scorn, ridicule and hatred against him.

By a cease and desist letter dated 29.3.2021, our firm, Rosli Dahlan Saravana Partnership (RDS) issued a demand to C4 Center. Immediately, C4 Center deleted the false and defamatory posts. C4 Center's solicitors also admitted that C4 Center's postings on Rosli Dahlan were false and defamatory.

In affirming its regret over the falsehood and slander, C4 has issued and published its unreserved, unequivocal and unconditional public apology on its website, Twitter and Facebook page, which is reproduced in full below:

APOLOGY BY C4 CENTER TO LAWYER ROSLI DAHLAN

1. C4 Center, an NGO that combats corruption and cronyism and an advocate of a clean, competent governance system, hereby make this unreserved, unequivocal and unconditional apology to Lawyer Rosli Dahlan in respect of a posting made on C4 Center's website, Facebook and Twitter on 25.3.2021 ("the Posts").  - c) That there was no basis to allege that Lawyer Rosli Dahlan had illegally, unlawfully, unjustly and unduly profited by pocketing monies in connection with the 1MDB asset recovery efforts;
 - d) That there was no basis to allege or imply that Lawyer Rosli Dahlan had defrauded the Malaysian Public by pocketing monies intended to settle 1MDB's liabilities.
