RDS Partnership Advises Atrium REIT On Its Private Placement and Special Unit Issuance

The Board of Directors of Atrium REIT Managers Sdn Bhd (Manager), the management company of Atrium Real Estate Investment Trust (Atrium REIT), has proposed to raise RM85.3 million via a private placement to third party investors (Private Placement) and a special issuance of units in Atrium REIT (Atrium REIT Units) to its major unitholder, Mr Chan Kam Tuck (Special Unit Issuance), to fund asset enhancement initiatives on its Atrium Shah Alam 4 industrial property.

The Private Placement was completed on 17 August 2022 resulting in the issuance of 40,925,000 Atrium REIT Units and total gross proceeds of approximately RM57.3 million raised.

The Extraordinary General Meeting to obtain unitholders' approval for the Special Unit Issuance was held on 27 October 2022 and an ordinary resolution was passed by Atrium REIT's unitholders approving the Special Unit Issuance. The Private Placement and Special Unit Issuance were based on the issue price of RM1.40 per unit and upon completion, is expected to raise proceeds of up to approximately RM85.3 million.
